#### 22/001 ELECTION OF CHAIR

Cllr Roe proposed, Cllr Hocking seconded, that Cllr G Gamble be elected to serve as Chair of the Parish Council for the 2022/2023 Council Year. Cllr Gamble, had been unable to attend the Meeting but had indicated his willingness to serve and it was **RESOLVED** that he be elected.
