# DRAFT MINUTES Annual Council Meeting

NOTICE OF MEETING – Public Notice of the meeting was given in accordance with Schedule 12, para 10 (2) of the Local Government Act 1972.

#### 23/001 ELECTION OF CHAIR

**Cllr J Newton proposed, Cllr F Twisse seconded,** that Cllr G Gamble be elected to serve as Chair of the Parish Council for the 2023/2024 Council Year. Cllr G Gamble, indicated his willingness to serve and it was **RESOLVED BY MAJORITY** that he be elected. Councillor G Gamble signed his Declaration of Acceptance of Office.

#### 23/002 ELECTION OF VICE CHAIR

**Cllr G Gamble proposed, Cllr E Allen seconded,** that Cllr E Hocking be elected to serve as Vice Chair of the Parish Council for the 2023/2024 Council Year.
