Prior to the commencement of the Meeting all Council Members signed their Declaration of Office.

#### 25/001 ELECTION OF CHAIR

Cllr W Roe proposed, Cllr A Hall seconded, that Cllr P Macdonald be elected to serve as Chair of the Parish Council for the 2025/2026 Council Year. Cllr P Macdonald indicated his willingness to serve and it was **RESOLVED** that he be elected. Councillor P Macdonald signed his Declaration of Acceptance of Office.

#### 25/002 ELECTION OF VICE CHAIR

**Cllr P Macdonald proposed, Cllr T Mead seconded,** that **Cllr A Hall** be elected to serve as Vice Chair of the Parish Council for the 2025/2026 Council Year. Cllr A Hall indicated his willingness to serve and it was **RESOLVED** that he be elected. Councillor A Hall signed his Declaration of Acceptance of Office.

#### 25/003 APOLOGIES FOR ABSENCE

#### 25/004 COUNCIL MEMBER VACANCY

Following the Parish Council Elections on the 1<sup>st</sup> May 2025 this Parish had an uncontested Election. 8 eligible persons had been nominated leaving 1 Member Vacancy that could now be filled by co-option. The Council determined that they could fill the Vacancy from an eligible person who had already indicated that they wished to be considered having been a previous Council Member. Following consideration **the Council agreed** that Fiona Twisse should be co-opted on to the Council. **Proposed Cllr S Woodhead, seconded Cllr G Gamble and RESOLVED.** Councillor F Twisse signed her Declaration of Acceptance of Office.

#### 25/005 CONFIRMATION OF CHEQUE SIGNATORIES

**Cllr P Macdonald proposed, Cllr A Hall seconded,** and it was **RESOLVED UNANIMOUSLY** that all Parish Council Members should be cheque signatories, with any two being authorised to sign. There was now a need to alter the bank mandate so that all Council Members were able to sign cheques.
